VIRTUAL MEETING CONDUCTED ON ZOOM.

Call to Order: The meeting was called to order at 7:03 pm by President Camden Yehle.

Pledge of Allegiance: Recited.

Quorum: Determination of quorum was made by the Membership Committee.

Consent Agenda: The Consent Agenda was passed with no objections.

Treasurer's Report: Highlights of the month's fiscal transactions were shared.

Board Reports:

Secretary Patti Fisher recognized the work on the Sports Field of Council Coordinator Tim Swezey.

Presentation: Mat-Su Borough Planning Services, "Projects of the Department":

Kim Sollien, Planning Services Manager, introduced her staff, Leta Borys, Adam Bradway and Kelsey Anderson. The group gave a detailed description of projects underway. These include: Community Comprehensive Plans, a Borough Comprehensive Plan, Historic Preservation Plans, Borough-wide Long Range Transportation Plans, the plan for a Metropolitan Planning Organization, a Safe Routes to Schools Plan, Bike and Pedestrian Plans, the Plan for the Arctic Winter Games.

Presentation: MEA Transition Line Preferred Route, Jennifer Castro; Electric Vehicle Charging Stations:

Jennifer and Will Klat, Project Engineer, showed the preferred route options for a transmission line from Palmer Fishhook to Pittman areas and siting for two new substations to supply power to the growing communities from Fishhook to Meadow Lakes. It is anticipated that the route will be finalized in November. There will be an open house on September 29th at Tanaina Elementary, 2550 Lucille St., from 6:00pm to 8:30pm, for public input.

Jennifer described the process of electric vehicle charging and gave the location of the charging stations planned for the Mat-Su.

Discussion of Gravel Issues in Meadow Lakes:

- Secretary Fisher reminded members of the Planning Commission hearing on Monday, September 20th, on the Conditional Use Permit (CUP) for the gravel pit on property adjoining the Council's property. This CUP includes the details for the operation of the gravel pit and also the plan whereby the Council would obtain, if approved by the Assembly, 40 acres at less than fair market value to be an addition to the existing Community Park. She urged members to attend the hearing or phone in their comments to the Commission.
- 2) The Sylvan Gravel Pit CUP is in process of advancing to a hearing of the Borough's Board of Assessment and Appeals. Anyone concerned about the Appeal should file an "Interested Party" form with the Borough Clerk's office.
